**AGREEMENT BETWEEN PRAIRIELAND ENERGY INC.,
and CUSTOMER,
FOR THE PROVISION OF CHILLED WATER SERVICE**

This is an agreement between the undersigned (hereinafter "Customer") and PrairieLand Energy, Inc. (hereinafter "PEI") to furnish chilled water to the Customer at the below service address until terminated as provided herein. This agreement shall continue to be in effect until 60 days prior written notice is provided by one party to the other.

Customer requests PEI to deliver chilled water to Customer's building located at the below named address, via permanent chilled water supply and return piping, and provide a chilled water Btu meter for the purpose of measuring chilled water usage, and internet access with a static address for central reporting of PEI's metering and operational data, at the Customer's expense. The meter shall be connected to the Customer's inside piping. Customer shall take all of its chilled water requirements from PEI and will not resell or redistribute the chilled water provided by PEI. Customer agrees to be bound by PEI's Terms and Conditions of Service and the rate for service received.

The initial term of agreement hereunder shall be one year. The initial term shall commence when PEI begins to supply chilled water hereunder and, after the expiration of such initial term, the agreement shall be automatically renewed each year for a period of one year. The Customer shall have the right to terminate service under the agreement on 60 days prior written notice to PEI; provided, however, that in the event of termination, all amounts due PEI shall forthwith be paid. PEI shall have the right to terminate service under the agreement on 60 days prior written notice to the Customer.

This agreement will be binding upon and inure to the benefit of the successors, legal representatives and assigns of the Customer and PEI.
