**AGREEMENT BETWEEN PRAIRIELAND ENGERGY INC.,  
AND CUSTOMER  
FOR THE PROVISION OF NON-RESIDENTIAL ELECTRICITY SERVICE**

---

This is an agreement between the undersigned (hereinafter "Customer") and PrairieLand Energy, Inc. (hereinafter "PEI") to furnish electricity to the Customer at the below service address until terminated as provided herein. This agreement shall continue to be in effect until 60 days prior written notice is provided by one party to the other.

Customer requests PEI to connect its electricity on the side of the building and to provide a meter for purpose of measuring the electricity and connection to the Customer's inside wiring.

Customer shall take all of its electrical requirements from PEI and will not resell or redistribute the power provided by PEI. Customer agrees to be bound by the PEI's Terms and Conditions of Service and the rate for service received. The customer's peak electrical demand is estimated to be \_\_\_\_\_ kw. The Customer agrees to contact PEI if its connected load is expected to increase.

The initial term of agreement hereunder shall be one year. The initial term shall commence when PEI begins to supply electric energy hereunder and, after the expiration of such initial term, the agreement shall be automatically renewed each year for a period of one year. The Customer shall have the right to terminate service under the agreement on 60 days prior written notice to PEI; provided, however, that in the event of termination, all amounts due PEI shall forthwith be paid. PEI shall have the right to terminate service under the agreement on 60 days prior written notice to the Customer.

This agreement will be binding upon and inure to the benefit of the successors, legal representatives and assigns of the Customer and PEI.
